# **REGISTRATION PAYMENT GUIDELINES**

These guidelines apply to ALL Langley Minor Hockey player registrations for any given season.

An LMHA player registration will not be considered complete until FULL payment is processed.

FULL payment is considered as follows...

- The registration cheque (must clear), e-transfer or money order is received by LMHA.
- The registration credit card payment is processed and/or automatic credit card payment schedule has been established. At a minimum, the deposit MUST be processed at the time of registration.
- An alternate payment plan has been requested and approved by LMHA.

If you have any questions with respect to registration and/or registration payments, please contact the <u>LMHA Administrator</u> for assistance.

## **REGISTRATION FEES**

- All player registration fees, including "A" (REP) evaluation fees, are due and payable at the time of registration; however, if you select to pay by installments using your credit card, the registration will be considered processed once the deposit has been paid at checkout. LMHA reserves the right to rescind registration if, for any reason, all agreed installment payments are not made on their due date(s).
- Full payment of OFFLINE payments (cheque, e-transfer or money order) must be received by LMHA within 14-days of completing registration to be considered processed.
- LMHA will consider alternate payment plans (post-dated cheques) under extenuating circumstances with proper LMHA Board approval. To apply for an alternate payment plan, please see the LMHA Registration web page. You must contact LMHA with your payment plan request (link to form available on the registration page) within 14-days of registration to be considered. Additional fees for this option will apply and the payments must be made as per the approval.
- If you have applied for <u>financial assistance</u>, you must keep LMHA informed of your application, approval and estimated funding date.
- Any registration fees not paid as of August 20<sup>th</sup> will be subject to a \$100 late payment fee and may jeopardize your participation in any evaluation skates.
- Any fees that remain unpaid as of September 15<sup>th</sup> will be subject to a further \$100 late payment fee
  AND ice times may not be allocated until all fees have been paid-in-full. The only exception to any
  of these deadlines would be where an alternate arrangement has been approved by the Treasurer,
  VP Administration and Registrar.
- If you are in a position of Financial Hardship, please reach out to the <u>VP of Administration</u> and we will do our best to work with you.

A dishonored payment will be subject to an immediate \$50.00 service charge per incident. Failure to resolve a payment issue immediately could result in the player's registration being suspended and has the potential of that player not being provided any ice times and/or selected to a team.

## **PAYMENT OPTIONS**

#### **CREDIT CARD**

If you pay in FULL by **credit card**, that payment is processes at the time of your online registration. If you selected installment payments, the initial 25% deposit will be processed at the time of registration and the subsequent payments will be automatically processed on June 15, July 15 and August 15 for the given season. All processing fees are the responsibility of the registrant.

#### **E-TRANSFER**

In you opt to pay by **e-transfer**, your payment must be made in FULL. Installment payments are not available by e-transfer. The transfer must be received by LMHA within 14-days of registration to langleymha@gmail.com. Please include the player's last name and division in the note/memo section.

### **CHEQUE OR MONEY ORDER**

If you pay by **cheque or money order**, once your online registration is complete, print a copy of the receipt/invoice and include this with your payment. Please include your players' name & division on your cheque.

There is a <u>secure black mailbox</u> outside of the LMHA office. To access the mailbox, enter the front doors of George Preston, head right and then go through the sliding glass doors to the stands. Keep right and push the blue door open. You will see a yellow LMHA sign beside the mailbox. The LMHA office is the first door past that on the right.
