## LMHA JERSEYS

I acknowledge that, as the parent and/or legal guardian of the player listed on this file, I have read and agree to follow these instructions:

- Hockey jersey bags are preferred for storing and transport to and from the arenas.
- LMHA jerseys will be worn for games only, not practices.
- Player and teams must use the LMHA supplied A's and C's and they must be sewn on – NO GLUE.
- Name bars or sponsorship patches must go on the back of the jersey and be sewn on below the number – NO GLUE.
- Any item that is glued on to a jersey will result in the player losing their jersey deposit.
- All name bars', C's, A's and any other alterations will be removed prior to returning your players jersey's.

I also acknowledge that:

- Once placed on a team for the season, I will provide the team manager with a post-dated cheque (April 1, 2019) made out to Langley Minor Hockey Association for the amount of either \$100 for Atom C teams and Initiation teams OR \$150 for all other LMHA teams.
- LMHA will cash the deposit cheque if my players jerseys are not returned to LMHA in the condition that they were received.
- If my players jerseys are returned after the final return date offered, no refund will be issued.
- If a deposit cheque does not clear or LMHA is unable to process it, the full deposit plus a \$35 admin fee will be added to my players next years registration.

I understand that it is my responsibility to keep the team Safety Person advised of any change in the above information as soon as possible.
